**Tonnage Duties.**—We find by the report of the proceedings of congress, on Monday, that the bill to repeal the tonnage duties on vessels of the United States, and certain foreign vessels, has been ordered to its third reading, by a vote of 94 to 78. We congratulate the mercantile community on this result which assures the passage of the bill in the house. Previous to taking this vote the bill was opposed by Mr. Gilmer with some warmth and at considerable length, on the ground that navigation was already sufficiently favored and that none of the existing duties ought to be remitted until the public debt was paid. Mr. Sprague replied, showing the severity with which the duty operated on the coasting and West India trade. Two unsuccessful attempts were then made to lay the bill on the table.—In the second of which the vote stood—yeas 82, nays 92. After a short speech by Mr. Reed in favor of the bill, further debate was arrested by a motion for the previous question made by Mr. Long and sustained by the House, and the bill passed to a third reading.

**Paris, 11th Jan. 1829.**  
 To the President.—I have made a bust of Lafayette, and would willingly raise a statue to his honor—not for himself, because he has no need of it, but for ourselves, who approve in so lively a manner the desire of honoring the illustrious hero of admiration with which we are inspired for him.  
 The youth of the French nation is filled with admiration for the virtues of the youth and the old age of him of whom I send you a likeness.  
 They envy the glory that was acquired upon the American soil, by the side of the immortal Washington, and the defender of your noble right.  
 They envy the glory which has been acquired on the soil of France, in the minds of the troubles of Paris and of Versailles, where, in breasting the storm, he lacked courage as little in the struggles of debate as when contending with the sword.  
 They envy that glory which covers his head with white with age, but still sparkling with the fire of liberalism and patriotism.  
 It is in the name of this youthful feeling of the French nation, ambitious to imitate every thing generous and great, that I offer you a work upon which my hands have been employed for some time, and with great care.  
 I could wish that it was more worthy of the subject—more worthy of the place which I am desirous to see it occupy.  
 Yes, Sir, I would wish that the bust of our brave General, our illustrious Deputy, should be elevated on a pedestal in the audience chamber of Congress near the monument erected to Washington to himself; that the son be placed to the side of the father, or, if you please, that the two brothers in arms, the two companions in victory, the friends of order and of law may be no more separated in our estimation, than they were in their devotedness to the national liberty and in the hour of peril.  
 Lafayette is one of the ties that unite the two worlds—he visited the new one to remain there for a few months, and for salute once more your sacred land of justice and equality; and has returned to us after having partaken of your feasts and received the honor and the benediction of your nation.  
 I hasten to render my homages in returns—I present you with my image. It will be a memento, that the original may often recall to the National Assembly those eternal principles upon which the independence of the State reposes, and which are the foundation of their safety.  
 I am with profound respect, Mr. President, your very humble and obedient servant,

The American Consul here immediately applied to the Superior Authorities, who promised that he should have every satisfaction. The insidious Commandant has been displaced and is to be tried, and no doubt is entertained that he will be broke. I will thank you to let this be known to my friends as well as to the executive, in order that they may take what steps they think proper to get redress for this stain on a citizen and the American flag. The Consul will report the particulars as soon as something is determined upon. I will proceed to Elizabeth City as soon as my business is settled, and shall hasten to Washington to obtain redress. In consequence of this ill usage, I am totally unable to write myself, and am obliged to employ a man to pen this for me."

**Another Patriot.**—We learn from Capt. Sperry, of the brig Actress, who arrived this morning from St. John Porto Rico, which place he left the 16th of January, that the Buenos Ayrean privateer brig Patriot, Capt. Almeida, had arrived there from a cruise of six months with six Spanish prizes. The crew rose on the 13th of January, and on the 14th brought her into Porto Rico, and delivered the Captain and vessel up to the Spanish authorities. The Captain was sent to the Mill and put in close confinement, and was never seen again.
