The parties having come to amicable settlement of their respective rights, agreeably to the schedule presented by the defendant in this case, marked A. and which is to remain among the Records of the Court, and the result of said statement showing in favor of the said plaintiff, in this case a sum of 3277 Dollars 97 cents, being the moiety of the profits of the community, including the sum of Five Hundred Dollars, being the amount of the dotal rights of the plaintiff. It is ordered, adjudged and decreed by the Court, with the consent of J. F. CASOPE, the attorney representing the said plaintiff, that she do recover from her said husband, Francois Auguste, the said sum of 3277 Dollars 97 cents, by privilege and preference out of all the property of the said community in full satisfaction of all her rights and claims to the same. That the said defendant remain responsible for and pay all the debts of the community as stated in the annexed schedule, that the property belonging to the said community now becomes the sole and exclusive property of the said defendant, on the conditions above mentioned, with a reservation in favor of the said Plaintiff of such rights only as may derive from any errors which may exist, in the settlement of her rights as appears by the schedule hereto annexed.
