perused private accounts from Poland which  
warrant this assertion. Without foreign aid  
they cannot succeed, and that aid they are not  
likely to obtain.

The Austrian troops do not meet with any  
check in Italy, and the Emperor is determined  
on putting down the revolt, and of supporting  
the Roman Pontiff. The renounces of  
France were disregarded in respect to the entry  
into the States of Bologna and Romagna. Na-  
tionalists were said by the French Minister to  
be carrying on, which he hoped would lead to  
favorable results. Such you may rely will not  
be the case. Austria is fully aware of the state  
of France, and defies her to act up to the threat-  
she held forth. England has been applied to,  
to act as a mediator, but refuses to take part in  
the affair; fairly stating that she has received a  
lesson in the affairs of Belgium, the representa-  
tive of France having signed Protocols in Lon-  
don, in conjunction with England, which were  
protested against by the foreign minister (Sobas-  
ki). War must take place between Austria  
and France, but I apprehend it will be declared  
by the former.

#### SIC TRANS GLORIA MUNDI.

The end of Military Glory.—It is estimated  
that more than a million of bushels of human  
and animal bones were imported last year from  
the continent of Europe into the port of Hull. The  
neighborhood of Linlithgow, Auldearn, Waterlooville,  
and of all the places, during the late bloody year,  
where the principal battles were fought, have  
been swept alike of the bones of the living and of  
the horse which bore them. Thus collected from  
every quarter, they have been shipped to the port  
of Hull, and thence forwarded to the Yorkshire  
bone-grinders, who have erected steam  
engines and powerful machinery, for the pur-  
pose of reducing them to a granular state. In  
this condition they are sent chiefly to Doncaster,  
one of the largest agricultural market-towns in  
that part of the country, and are there sold to  
the farmers to manure their lands. The oily  
substance evolving as the bone calcines makes it  
a more substantial manure than almost any other  
substance—particularly human bones. It is  
now ascertained, beyond a doubt, by actual ex-  
periment upon an extensive scale, that a dead  
soldier is a most valuable article of commerce;  
and for aught we know to the contrary, the good  
farmers of Yorkshire are, in a great measure,  
inclined to the bones of their children, for their  
bread. It is certainly a singular fact, that Great  
Britain should have sent out such multitudes of  
soldiers to fight its battles upon the continent of  
Europe, and should their imitations be an  
article of commerce to fatten their soil.
