MISCELLANY.

MURDER.—Extract of a letter to the Editor of the Newbern, N. C. Sentinel, dated Jericho, Duplin County, 1st June, 1831.—“On Sunday last a murder was committed in this neighbourhood, which has created a very unusual sensation. About 11 o'clock that day, Miss Nancy Boyet, daughter of a very respectable widow, left her house with the intention of visiting Mr. Price's family, who live at the distance of a mile from her mother's. When night approached, and her daughter still absent, Mrs. Boyet became uneasy, and set out with the hope of meeting her on the way. Her feelings may more easily be imagined than described when she found on her arrival at Mr. Price's, that her daughter had not been there that day. She alarmed the neighbours, a company went forth, and after a diligent search they found the mangled corpse of the unfortunate victim in an adjoining pond. Her body was shockingly bruised, and her throat was cut to the back bone. From appearances, the murder must have been perpetrated at a distance of two hundred yards from the pond in which the body was found, and the resistance must have been desperate. The ground and bushes at the place of conflict, were much trodden and broken, and some light wood limbs that were on the spot, appeared to have been used by the monster in completing his designs. The young lady's comb was also found broken and scattered on the ground. No discovery leading to the detection of the murderer, has yet been made, and with the exception of its fatal result the whole transaction is yet a mystery to the neighbourhood. It must have taken place about noon, in a thickly inhabited settlement on the public road leading from Whitehall to Fayetteville. An inquest was held, and a verdict pronounced of 'rape and murder, by some person unknown.' Should any thing further transpire concerning this lamentable deed, I shall take an early opportunity of communicating it.”

A Convention will shortly be held at Estillville, in the western part of Virginia, to determine upon the best route for connecting the western rivers with some of the South Atlantic Seaports. Charleston, (S. C.) whose enterprising commercial capitalists are constantly operating their own and the public interest, has appointed Mr. Poinsett, Mr. H. Allen an Engineer, to attend the Convention for the purpose of representing the strong claims which this city presents to the benefits of furnishing the entrance of the supplies which may, by these means, with the additional facilities be carried into the interior. This improvement in the means of transportation, would no doubt enable their city to afford the outlet which some of her citizens attribute to the Tariff. In any point of view, it would certainly add greatly to the commercial importance of Charleston if this scheme should be carried into effect. Our neighboring State of Georgia, is actively engaged in works of Internal Improvement, whilst South-Alabama is infested with a set of pretended politicians who are afraid of injuring the Chicken and Butter market by the improvement of our great highways. Artificial Spermatozoa.—When the method of making artificial Spermatozoa had become newly known, Doctor Schmeisser, of Hengshurg, formed a quantity from some half decayed human muscles, by means of nitric acid, and making it into candles, sent some of them to Blumenback, with a notice that they were prepared from the legs of a man, who in his life time had done no good. Upon which this veteran naturalist observed, “Mortui lucent, qui viva obscuro fuerunt.” (They shine in death, who in life were obscure.)

The St. Augustine Herald mentions that the gale of the 10th ult which produced the highest tides here, was very severe. That paper says:—“The tides were much higher, by two or three feet, than the ordinary spring tides. The damage in the city is considerable, but south, so far as we have heard, it has been very serious. At New Smyrna, a house in which Mrs. Dunham had established a temporary residence, was blown down a few minutes previous to its being abandoned by that lady and her family, and the furniture lost. The carriage house of Mr. Bulow was blown down and about 20 negro houses, Mr. Darley's crop much injured. At Col. Dumaine's, some out houses blown down. At Forch's & Mazer's, a crop lost. At Hernandez' and Griswold's, the gable end of a curing house blown down, but no other injury sustained—the cane crop promising. North of the city we have not heard that any damage has been sustained. No vessels were in the harbor, except the Sam Patch, which was blown high and dry, but not damaged.

The corn crops on the sea board have been lost in consequence of the drought. The schr. Southern Trader, Huntingdon, (late Uptogrove) was driven ashore, about 12 miles south, during the gale, and totally lost.

The Easton Whig of the 17th June says:—Last Sunday morning was found afloat on the Delaware, opposite Kensington, a box containing two infant children, dead. They were passed among ravings, and the box was nearly full of water.

PARISH COURT for the parish and city of New Orleans.—Present the Hon. James Pitot, Marthe Clara Levee, the wife of Wm. T. Thompson, ss. Wm. T. Thompson. The petitioner in this case having been separated from bed and board upon grounds of excesses, ill treatment and outrages on the part of her husband Wm. T. Thompson, by judgment of this Court dated July 21st. 1828, has sued her said husband, the defendant to the present case, for a divorce; pursuant to the 4th section of the Statute, thereupon, and approved on the 18th of March 1827; and the defendant in his plea has alleged that if the said petitioner is entitled by law to the divorce she has applied for, he on his part is now entitled to the custody, care and superintendance of the son whom the parties had together, and that for motives of advantage to the said child, expressed in his answer and to be shown by him at the trial of the case.—Whereupon the case having been regularly set for trial several times, and upon the non appearance, at the last of them, of either the defendant in person, or of his counsel on records, the petitioner's counsel on her part, having insisted for the judgment of the Court in the case, and submitting it upon both said records and those of the preceding judgment aforesaid, for the separation of bed and board between the parties, and for the judgment of the Court in two years, having expired since the separation from bed and board between the parties and that no reconciliation had taken place between them, and finally, that nothing, on the part of the defendant has been shown for the alteration of the decree of this Court, in the preceding judgment of separation from bed and board, with regard to the disposition of the child. It is ordered and decreed now that judgment be rendered in this case against the defendant with the costs of suit, in favour of the petitioner, and that a divorce between them being thereby pronounced, they are now placed, with respect to each other in the same situation, as if no marriage had ever been contracted between them.
