An article appeared in the French part of our paper of Thursday last, which has called for some statistics from the Mercantile Advertiser.

The Prussian Official Gazette states that the insurance has again broken out in Volhynia.

HOLLAND AND BELGIUM.

They hope much from the vote of the Chambers on the paragraph of the address relating to Poland, and above all, from the amendment which will be offered, the purpose of which will be, that the independence of Poland shall be acknowledged.

ORDER OF THE FRENCH ARMY.

SOLDIERS.—The army has been called upon to protect the independence of the nation which France ranks as first among its friends. His Majesty the King of the Belgians will not have called in vain for aid of the French nation. The Dutch, who lack the bravery of the Belgians, have again defied that nation, and are jeopardizing the peace of Europe in defiance of the Powers who have unanimously guaranteed the independence and neutrality of Belgium.

BRUSSELS—Friday Aug. 12.—This city was in a most dreadful state of agitation this morning. The Dutch having advanced within eight miles of Brussels, the drums at an early hour beat to arms, and the inhabitants were flying in every direction.
