English Journals on Interfere No. 9.

The latest English journals received in the city are not in agreement in their views with regard to the probability of interfering in the difficulties between the North and the South. The London *Weekly Dispatch*, and the *Standard*, has a long article on the subject, in which it strongly opposes the proposition, and maintains a very remarkable state of feeling. It commences by saying, "We were never and shall not disclose our distrust and fear of the American Republic." We did not seek to control our opinion that it was better to let things alone, than that we were more likely to profit in endeavoring to do so; but it should be so difficult to us to be formidable to mankind." Further on it says, "France and England are threatened with war if they interfere between the combatants. Why should they? The belligerents have only two ways to make each other too weak for the purpose of any such settlement that may be proposed. Mutual exhaustion is rapidly breaking up the political and social system of the Federation; the longer the contest continues, and the greater the efforts that must be spared, the more invincible they must become. They will bleed each other to the last drop—they will ruin each other down to the last dollar in their pockets—what more needful than their mutual destruction?"

A report from the Library of Philadelphia comes to us. It states that Capt. Thomas Blunt, was ordered to leave the State—the first by 9 o'clock the following morning, the other two by noon on the following Thursday.
