CHARTER

STATE OF LOUISIANA, PARISH OF ORLEANS, CITY OF NEW ORLEANS

BE IT KNOWN, That on this fifth day of October, in the year of our Lord, One thousand nine hundred and seven, the undersigned...

ARTICLE I. The name of the corporation shall be THE COUNTESS LUMBER MANUFACTURING AND EXPORT COMPANY, INC.

ARTICLE II. The domicile of this corporation shall be in the City of New Orleans and the Parish of Orleans, State of Louisiana.

ARTICLE III. The capital stock of this corporation is hereby fixed at the sum of five million dollars, divided into and represented by five hundred thousand shares of the par value of ten dollars each.

ARTICLE IV. The capital stock of said corporation is hereby fixed at the sum of five million dollars (\$5,000,000) divided into and represented by five hundred thousand shares of the par value of ten dollars each.

ARTICLE V. All the corporate powers of said corporation shall be vested in and exercised by a Board of Directors to be composed of three stockholders.

ARTICLE VI. Wherever this corporation may be dissolved, either by limitation or from any other cause, its affairs shall be liquidated by two commissioners to be appointed among the stockholders...

ARTICLE VIII. No stockholder shall be held liable for the contracts or debts of said corporation in any further sum than the unpaid balance of the stock owned by him...

ARTICLE IX. D. A. Hackney, R. H. Hackney, and William J. Young have been chosen and selected as the first Board of Directors of this corporation with R. H. Hackney, as President, D. A. Hackney, as Secretary-Treasurer, to serve as such until the fifth day of October, 1907, or until their successors shall have been elected and qualified.
