CHARTER.

UNITED STATES OF AMERICA, STATE OF LOUISIANA, PARISH OF ORLEANS, CITY OF NEW ORLEANS.

BE IT KNOWN, That on this Thirteenth day of August, 1907, in the year of Our Lord One thousand nine hundred and six, and of the Independence of the United States of America, the undersigned, Ernest Toussaint, Mayor of the Parish of Orleans, Louisiana, duly constituted and qualified, and in the presence of the witnesses hereinafter named and understood, have caused to be signed and subscribed by those names as hereinafter mentioned, the following Charter, which they have solemnly declared that availing themselves of the powers relative to the organization of corporations and especially of Art No 26 of the Constitution of Louisiana, they have organized, and do hereby organize, a corporation, the name of which is as follows: The Charter of the...

ARTICLE I. The name and title of the corporation hereby formed is declared to be the H. W. SLOAN COMPANY, LIMITED, and shall mean the said company, which shall be organized for the purpose of the business of the company, and the powers conferred by law upon corporations.

ARTICLE II. The objects of this corporation shall be to do all such business as may be necessary for the carrying out of the objects of the company, and the powers conferred by law upon corporations.

ARTICLE III. The objects and purposes for which this corporation is organized and the nature of the business to be carried on by it are hereby declared to be the carrying out of the objects of the company, and the powers conferred by law upon corporations.

ARTICLE V. All the shares of this corporation shall be held by the office of said corporation, and the same shall be distributed by the Board of Directors, and the holder of any share shall be entitled to all the rights and privileges of a shareholder in the corporation.

ARTICLE VI. All elections shall be by ballot, and held at the office of said corporation, and the same shall be distributed by the Board of Directors, and the holder of any share shall be entitled to all the rights and privileges of a shareholder in the corporation.

ARTICLE VII.
