BE IT KNOWN, That on this fifth day of October, in the year of our Lord, One thousand nine hundred and eight, and of the Independence of the United States of America, the one hundred and thirty first.

CHARTER

STATE OF LOUISIANA PARISH OF ORLEANS

BE IT KNOWN, That on this fourth day of September, in the year of our Lord, one thousand nine hundred and eight, before me, J. Q. DAVEY, Jr., a Notary Public duly commissioned and qualified, and in the presence of the witnesses named, and undersigned, personally appeared the following persons, whose names are hereunto subscribed, who severally declared that availing themselves of the State of Louisiana, they had each such made and provided and particularly of the provisions of Act 78 of the acts of the Legislature of Louisiana, approved July the 4th, 1904, they have consented and agreed to do by these presents consent and agree and bind themselves, as well as all such persons as may hereafter become associated with them to form a corporation and to do all such things and under the articles and stipulations following to-wit:

ARTICLE I.

The name of this corporation shall be the CONSUMERS LUMBER AND CUTTING AND EXPORT COMPANY, and under the said corporate name it shall have power and authority to have and enjoy corporate existence for the full term and period of twenty years, from and after the date hereof, and to be renewed, to make and use a corporate seal and the same to alter and break at pleasure; to hold and receive, lease, purchase, and convey, as well as mortgage and hypothecate property real and personal, and to do all such things as may be necessary and proper to carry out the purposes of this corporation.

ARTICLE II.

The domicile of this corporation shall be in the Parish of Orleans and the State of Louisiana, and the office of the President and Vice-President shall be in the Parish of Orleans and the State of Louisiana.

ARTICLE III.

The objects and purposes for which this corporation is organized and established, and the nature of the business to be carried on, shall be to buy, sell, transport, store, and otherwise dispose of, and to manufacture, produce, own and sell timber, and to do all such things as may be necessary and proper to carry out the purposes of this corporation.

ARTICLE IV.

The capital stock of this corporation is hereby fixed at the sum of Fifty thousand dollars (\$50,000) divided into five hundred shares of \$100.00 each.

ARTICLE V.

The corporate powers of this corporation shall be vested in and exercised by a Board of Directors to be composed of three stockholders to be elected annually on the 5th day of October of each year.

ARTICLE VI.

The Board of Directors shall have full power and authority to do all such things as may be necessary and proper to carry out the purposes of this corporation.

ARTICLE VII.

Whenever this corporation may be dissolved or liquidated, the assets of the corporation shall be sold and the proceeds thereof distributed to the stockholders.

ARTICLE VIII.

This corporation shall have the right to sue and be sued in any court of law or equity.

ARTICLE IX.

The Board of Directors shall have the right to make and alter the by-laws of this corporation.

ARTICLE X.

This corporation shall have the right to acquire and hold real and personal property.

ARTICLE XI.

The Board of Directors shall have the right to borrow money and to issue bonds.

ARTICLE XII.

This corporation shall have the right to execute and be bound by contracts.
