CHARTER

UNITED STATES OF AMERICA STATE
OF LOUISIANA PARISH OF OR-
LEANS CITY OF NEW ORLEANS
WHEREAS in the month of February in the year
One Thousand One thousand nine hundred and six
and of the Independence of the United States
of America, one hundred and eight years ago,
in the year of our Lord One thousand nine hundred and
sixty nine, the Legislature of the State of Louisiana
and the Parish of Orleans, by their respective
assembled legislatures, adopted and enacted
the following resolutions, and appointed the
persons to whom the same were directed,

ARTICLE I

The name and title of incorporation hereby
formed is directed to be the H. W. HUDD
COMPANY LIMITED, under which name
shall have and enjoy corporate existence for
the period of ninety-nine years, and shall have
and exercise for the purposes of the business
to be conducted by it, the powers conferred
by law upon corporations.

ARTICLE II

The domicile of this corporation shall be in
the City of New Orleans, Louisiana. A notice
or other legal process shall be served on the
President or the Company, or in his ab-
sence, on the Secretary and Treasurer.

ARTICLE III

The objects and purposes for which this corpora-
tion is organized and the nature of the busi-
ness to be carried on by it are expressly declared
to be the conducting of the business of pur-
chasing and selling, or either on orders or
the exporting of cotton and other commodities
to foreign countries, and of advertising the
same, and for advertising, by letter, cable or
otherwise, the products and services of its
corporation and corporation, and to transact
any other business or transaction which may
arise in connection with carrying on the busi-
ness and for the purpose of purchasing or
