BE IT KNOWN That on this Fourteenth day of the month of December, in the year of our Lord, One thousand nine hundred and ten...

ARTICLE I. The name and title of the corporation here by formed is declared to be the GREEN PARK HOTEL COMPANY...

ARTICLE II. The domicile of this corporation shall be in the city of New Orleans, Louisiana...

ARTICLE III. The objects and purposes for which this corporation is organized and the nature of the business to be carried on by it are hereby declared to be the carrying on of a hotel...

ARTICLE IV. The capital stock of this corporation is hereby fixed at the sum of one hundred thousand dollars, divided into one hundred and twenty shares...

ARTICLE V. The corporate powers and authority of this corporation shall be vested in a President, a Secretary and Treasurer and two Directors...

ARTICLE VI. Elections shall be by ballot and held at the office of said corporation under the supervision of a committee to be appointed for that purpose...

ARTICLE VII. Both the stockholders subscribing to this charter and a future stockholder agree mutually with each other not to dispose of their stock without first giving notice to the other stockholders...

ARTICLE VIII. No stockholder shall ever be held liable or responsible for the debts or liabilities of this corporation in any manner...

ARTICLE IX. At the termination of this charter by limitation of time or otherwise the business and affairs of this corporation shall be liquidated...

This act of incorporation may be changed, modified or altered, or the corporation may be dissolved by a vote of three-fourths of the capital stock represented at a general meeting...
