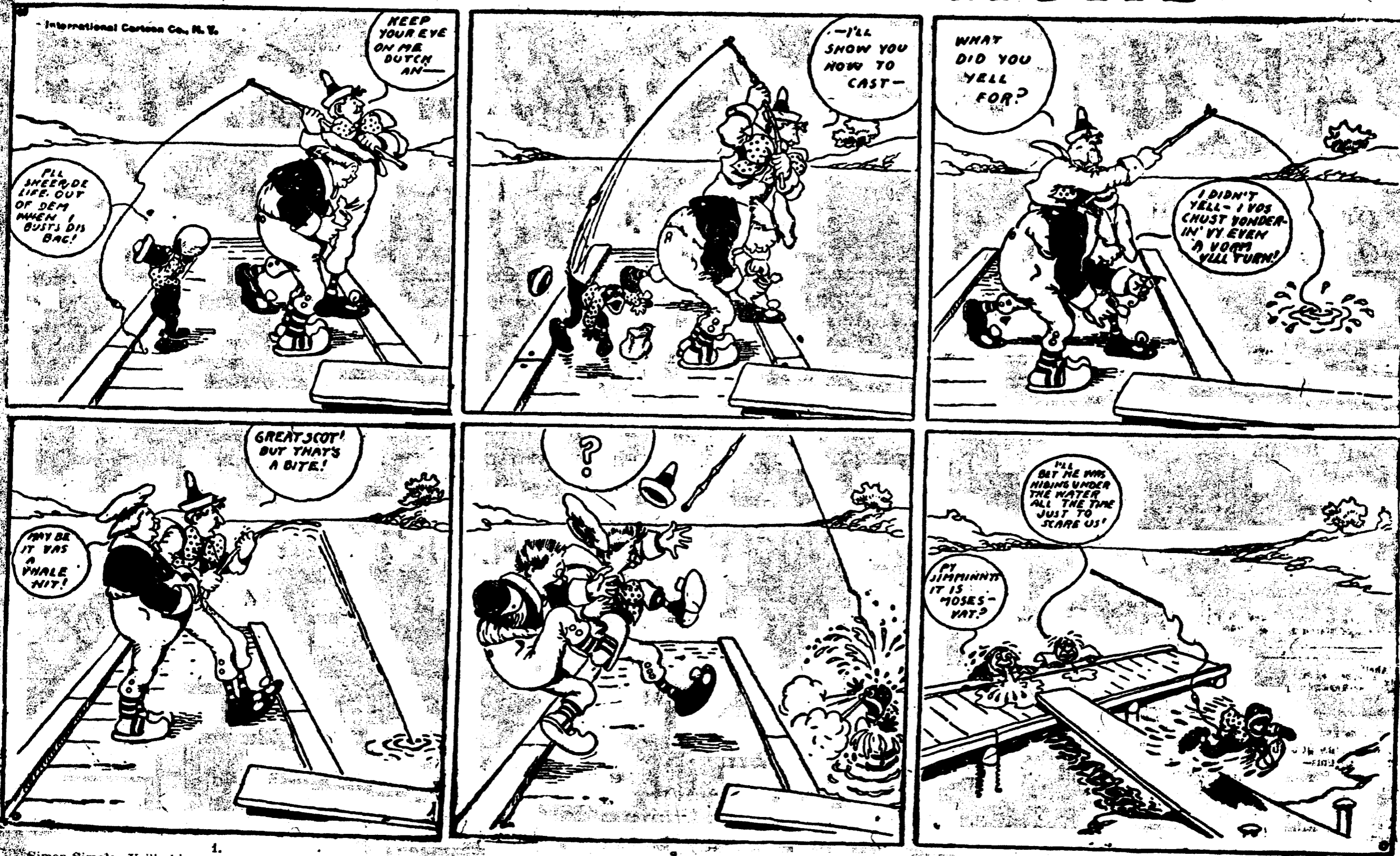


118 SIMON SIMPLE GETS A BITE
