HAPPENINGS 69 YEARS AGO.

A correspondent of the Statesman has the following to say in describing the battle field of Cerro Gordo:

"I never desire to visit another such field after battle...."

The gorge was choked up with the bodies of the flower of the Mexican army. The wolf-dog and the buzzard howled and screamed as I rode by, and the stench was too sickening to endure.

Passing on, we came to the hospital where the badly wounded lay — the Mexican first, and next the Americans. I could not but notice the difference between them. The wounded Mexicans cannot endure fire and pain like the American — quick and impetuous, they will for a moment face danger and death like heroes, but the long tedious hours of sickness or pain or a lasting battle in which men are required to overcome extraordinary artificial and natural obstacles, are too much for them. They have all the blaze of burning shavings, not the lasting fire of the burning coal.

Referring to the paving of Prytania Street, the following extracts from the minutes of the city council of July 19th, 1847, and signed by F. Bouigny, Mayor, appears: "The work of paving Prytania Street will cost probably \$30,000 and perhaps not more than 300 persons pass over it each day from Jackson Street — few persons pass on this street who do not reside on it, — etc."

The same council meeting passed the following resolution: That from and after the first of September next, all omnibuses running in or through the city of Lafayette, shall be requested to have numbers placed on them, according to an ordinance of the General Council of the City of New Orleans, and an act of the Legislature of 1844 — and that all omnibuses, at night, carry lighted lamps; and any failure to comply with this law shall subject the party to fine, etc.
