REPORT OF MRS. BRANCH K. MILLER.

Treasurer of the Secours Louisianais à la France at the meeting February 23rd.

To the President and Members of the "Secours Louisianais à la France": Ladies, I beg to present this statement of the finances of the "Secours Louisianais à la France" for 1916.

Since our organization in January 1916, I have made reports at the meetings of the heads of the bands; I now give you a full statement of the financial condition of the "Secours" during its first year of existence.

We have received from subscriptions, \$1,643.45; Mrs. W. Mason Smith's tea and bridge and donations from friends to card party, \$328; entertainment given jointly with the "Société du 14 Juillet", \$493.45; gala fête at Hotel Grunewald, November 20, given jointly with Queen Mary's Guild, \$380.91; individual donations, \$352.48; total amount received, \$3,198.29; money expended for material, insurance, etc., \$2,251.26; balance, \$947.03.

This report ends with January 1, 1917. Since then a large portion of this balance has been spent and will be accounted for in next year's report as well as the donations received since January 1, 1917.

International Peace.

The proceedings of the great conference held in New York in 1913, preliminary to the contemplated celebration in 1915 of the one hundred years of peace between English-speaking people, have been published in pamphlet form. Mr. W. O. Hart, who was a member of the conference, is distributing copies to libraries and colleges in the State, as the plan laid out and the addresses made constitute a valuable contribution to patriotism and history. One of the most interesting parts of the publication is a letter from Cardinal Gibbons approving in everything the contemplated celebration which, however, had to be given up on account of the European war, the only celebration of the occasion being that in New Orleans, which was pronounced by eminent men from all over the United States and Canada, who attended to be the greatest patriotic event in the history of America.
