Mr. W. O. Hart, a member thereof and also of the executive committee of the Louisiana Child Labor Committee, has written to our Senators and Representatives asking their support to the bill. It is hoped it will pass during the present Congress, if not, the law will become a dead letter and the work for the appropriation will have to be begun all over again. As is generally known, Louisiana has taken an advanced step in child labor laws and all that is needed to give full effect to its laws is the putting into effect of the Federal law.
